NARRATIVE

ATH243- The following incident was recorded on my BWC243 and uploaded under the report number. I did not review the video prior to writing this report. See BWC for further.

On 3/3/25 at approximately 0951 hrs, at the direction of Sgt. Bush, myself, Ofc. Callas and Ofc. Logarta and Sgt. Bush responded to the rear [Private information 5 ILCS 140/7-1(b)] where the property line meets Mundelein Park District property (1401 N Midlothian Rd.) in an attempt to speak with Holm, James F (M [Invasion of personal] homeless) who has been camping for the past several weeks.

On 3/2/25 at 0830 hrs, Ofc. Purdue spoke with Holm's and verbally advised him that he has 24 hrs to remove his tent and personal belongings from Park District Property or it maybe removed by PW or MPD and brought back to MPD where he can pick it up. He was further advised he may be cited for violating local ordinance O-24-10-51-1 (public camping). Reference case number 2025-00007585 and 2025-00007500.

We located Holm's in his tent in the rear of [Private information] but on Mundelein Park District Property (1401 N Midlothian Rd.) next to a sign that stated the area was "federally protect wetlands". Holm's was again offered assistance in obtaining long term shelter however he declined, collected several personal belongings from his tent and began to walk away. The rest of his personal property was collected, transported back to MPD where it was placed into a large evidence bag and labeled as personal property awaiting Holm to retrieve it. Holm's was further issued a local ordinance citation for public camping and advised of his court date.

It should also be noted that Holm's has been verbally trespassed from [Private information] at the request of the homeowner, Craig, Daniel due to Holm walking thorough his backyard to get to his camp, however Craig has yet to want to pursue charges. Reference case report 2025-00005972 and 2025-00005974.

No further case closed.

PV228: This incident was recorded on Axon III body worn camera #228 and saved under the above report number. The video was reviewed prior to completing this report.

In summary:

On 5/24/25 at 7:13pm, I was dispatched to [Redacted] Private information 5 ILCS for a report of a suspicious subject. Upon arrival I spoke with Andrey Ash. Andrey advised he had seen a subject camping, near a walking path located south of Turnberry, west of Mechanics Grove Elementary, for the last three days. Andrey said he was concerned as to why the subject was there and possible safety for kids who may walk by.

The area was checked and I located the subject, known to me as James Holm. James was located behind various bushes and trees. I observed bags containing his belongings on the ground around him and it appeared that he was sleeping in that area. I advised James he had to pack up and leave. James gathered his belongings and began to walk away. I told James he was not free to go and that he had to go with us back to our vehicles for some paperwork. James followed to my vehicle. I issued James a non-traffic citation for public camping-second offense with a notice to appear on 6/16/25 at 9:00am at the Mundelein Branch court house. While issuing the citation, Ofc. Rodriguez and myself offered assistance to James multiple times and he declined all help. James was sent on his way and once again advised he can not camp within the village of Mundelein.

I advised her to call the PD and ask to speak with a watch commander. Kelsey thanked me for my time and hung up.

I located Holm at the Fremont Public Library and confirmed that the tent was his. Holm advised that he would have it removed later today. I advised Holm of Mundelein's no camping ordinance and to contact the MPD if he needed assistance. Holm advised that he should not need any assistance because PADS provided him with the tent and blankets to keep warm. I returned to Barefoot Bay and advised Kelsey and Kyle of my findings. They advised that it was ok for the tent to stay there until Holm's removed it. Kyle advised that he has been in contact with Cmdr Kisselburg about Holms and asked that I speak with him. I contacted Cmdr Kisselburg and he advised that Ofc Glogovsky was trying to locate Holms because he had arranged housing through the Salvation Army. I contacted Ofc Glogovsky who advised to have Holms contact him on Monday after 0800hrs and he would assist Holms with the housing.
